

STAR+PLUS long-term services and supports provider update

Summary: Effective September 1, 2019, Amerigroup will make updates to the *STAR+PLUS LTSS Billing Matrix*. Additional changes include claims billing revisions. Long-term services and supports (LTSS) training sessions are also upcoming.

Billing codes

All claims are required to be billed with a procedure code, modifier (if applicable) and the appropriate place of service code in order for the claim to be reimbursed accordingly. LTSS services must be billed according to the Amerigroup *STAR+PLUS LTSS Fee Schedule*. Ensuring the correct procedure code, modifier and incremental units are billed appropriately is important.

The correct financial management service-fee procedure code and modifier must be billed with the correct consumer-directed services model service.

Claims billing changes for agency model providers:

- Claims with dates of service on or after September 1, 2019, will need to be billed through TMHP:
 - Submit a new claim to Amerigroup for dates of service before September 1, 2019.
 - Submit a new claim to TMHP for dates of service on or after September 1, 2019.
- If claims with dates of service on or after September 1, 2019, are submitted to Amerigroup, the claim will be rejected, and the provider agency will need to submit the claim to TMHP.
- Claims cannot overlap the date of service with a date of service before and after September 1, 2019. If the claim contains dates of service that overlap, the claim will be rejected.
