

Federally qualified health centers and rural health clinic modifier requirements

Summary of update: Federally qualified health centers (FQHCs) and rural health clinics (RHCs) are required to bill with the appropriate modifiers according to the *Texas Medicaid Provider Procedures Manual (TMPPM)*. Effective July 1, 2021, Amerigroup may deny or recover claims that are not billed with the required FQHC and RHC modifiers.

FQHC modifier requirements:

- General medical services must be submitted using one of the appropriate modifiers: AH, AJ, AM, SA, TD, TE, TH, U1, U2, or U7.
- Family planning services and annual family planning examination must be submitted using one of the appropriate modifiers: AH, AJ, EM, U1, or U2.
- Texas Health Steps (THSteps) medical services must be submitted using modifier EP in addition to one of the appropriate modifiers: AM, SA, or U7.

RHC modifier requirements:

- General medical services must be submitted using one of the appropriate modifiers: AH, AJ, AM, SA, TD, TE, TH, or U7.
- Family planning services performed in the RHC setting must be billed with the appropriate modifier: AM, SA, or U7.
- THSteps medical services must be submitted using one of the appropriate modifiers: AM, SA, or U7.

Modifiers to use for services performed:

Modifier	Service performed
AH	Services performed by a clinical psychologist
AJ	Services performed by a clinical social worker
AM	Services performed by a physician; team member services
EP	Use to indicate THSteps services (FQHC only)
FP	Use to indicate that the service was part of an annual family planning examination
SA	Services performed by an advanced practice registered nurse or certified
	nurse-midwife in collaboration with physician
TD	Services performed by a registered nurse
TE	Services performed by a licensed vocational nurse

Modifier	Service performed
TH	Use to indicate the encounter is for antepartum care or postpartum care
U1	Services performed by a licensed professional counselor
U2	Services performed by a licensed marriage and family therapist
U7	Services performed by a physician assistant other than assistant at surgery
