### **Background**

On March 5, 2020, Governor Larry J. Hogan, Jr., declared a state of emergency due to disease ("COVID-19") caused by the novel coronavirus. An outbreak of disease due to COVID-19 first occurred in the Hubei Province, China, in late 2019, and has currently been detected in more than 109 countries, including the United States. COVID-19 is a severe respiratory disease, resulting in illness or death, caused by person-to-person spread of the novel coronavirus.

### **Telehealth Program Guidance**

The Maryland Department of Health Medical Assistance Program ("Maryland Medicaid") has recently updated the billing codes for its Telehealth Program for certain provider types. These changes are effective as of March 5, 2020, and will remain in place after the end of the state of emergency.

Below is a list of procedure codes for physical therapy, occupational therapy, speech language pathology, and nutritional counseling services that may be appropriate to be provided via telehealth. Please note that occupational therapy, speech therapy, and nutritional counseling services are only covered for Medicaid participants under the age of 21 unless the participant is enrolled in the Rare and Expensive Case Management (REM) Program. Services delivered via telehealth using two-way audiovisual technology assisted communication should be billed using the "-GT" modifier. None of the services listed below requires prior authorization from Maryland Medicaid.
