### Postpartum checkups



### Summary

According to the Healthcare Effectiveness Data and Information Set (HEDIS<sup>®</sup>) benchmarks developed by the National Committee for Quality Assurance (NCQA), new moms should complete a postpartum checkup 7-84 days after birth.

Amerigroup Community Care encourages providers to educate new moms on the importance of postpartum checkups. The American College of Obstetricians and Gynecologists (ACOG) recommends that all new mothers be seen by their OBGYN provider within the first three weeks for a postpartum checkup. This initial evaluation should be followed up with ongoing care, as needed, concluding with a comprehensive postpartum exam no later than 12 weeks postpartum.



# Why are postpartum checkups important?

It is easy for a patient who has just had a newborn to forget to take care of herself. As a postpartum care provider, you have the opportunity to educate new moms on the importance of postpartum care and encourage them to complete this important visit.

The postpartum visit is an opportunity for the provider to address:

- Complications that occurred during pregnancy.
- Underlying medical conditions.
- Health of the infant.
- Breastfeeding.
- Maternal/infant bonding.
- Depression screening.
- Sexual activity and plans for contraception.

We know how important it is for you to meet HEDIS measures. The postpartum care HEDIS measure looks at the percentage of patients who had a postpartum visit that included a pelvic exam or postpartum care on or between 7 and 84 days after delivery.

#### Get your efforts on record

Make sure your medical records reflect:

- The date of the postpartum visit.
- Evidence of one of the following:
  - Pelvic exam
  - Evaluation of weight, blood pressure, breasts and abdomen (notation of breastfeeding is acceptable for the evaluation of breasts component)
  - Notation of postpartum care (e.g., postpartum care, postpartum checkup, six-week check) or a preprinted postpartum care form in which information was documented during the visit

## Incentive for providing postpartum care

Providers are eligible to receive enhanced reimbursement in addition to the already established fee schedule for providing postpartum care. Use the CPT® Category II code **0503F**, defined as *postpartum care visit*; this code will help with HEDIS data collection and offers providers a \$20 incentive payment. Procedure code 0503F can be billed alone or with other qualifying CPT codes. For more information, please contact your local Provider Relations representative.

HEALTHY REWARDS	

Amerigroup members enrolled in our Healthy Rewards program can earn a \$50 incentive for completing a postpartum checkup between 7-84 days after delivery. If her Medicaid benefits offered by HealthChoice are going to expire after she gives birth, encourage her to have a follow-up exam before she loses coverage.

### **Helpful tips**

- If the patient comes in one or two weeks after a cesarean section delivery for a postsurgical check or the removal of staples, educate her on the importance of new moms coming back for a visit 7-84 days after birth.
- Call patients to schedule the postpartum visits as well as remind them of their appointment dates and times.
- Follow up with patients who miss appointments and reschedule.
- Make sure the postpartum checkup date is on or between 7-84 days (a day early or a day late does not count).
- Make sure the postpartum date is on the claim.
- Document all services using the ACOG forms.

### **Obstetrics policy billing changes**

Bundled obstetrical delivery CPT codes that include postpartum care are no longer reimbursable. The most appropriate delivery-only CPT code is to be submitted for the delivery itself. The specific postpartum care CPT code may be used for billing that service when the postpartum visit occurs.

Procedure code	Code description
59409, 59612	Vaginal delivery only
59514, 59620	C-section delivery only
59430	Postpartum outpatient visit
