## Quick information on the Maryland public behavioral health system:

- Optum Maryland manages adult residential treatment services for substance use disorders (SUDs).
- Medication-assisted treatment (including buprenorphine and vivitrol) for SUD is available in multiple treatment settings in addition to traditional opioid treatment programs.
- Expanded services for the treatment of gambling disorders is offered by SUD treatment programs.
- Reimbursement is not given to laboratories for definitive urine drug screens greater than 14 substances.
  The Maryland Department of Health (MDH) recommends providers use the American Society of
  Addiction Medicine Smart Testing guidelines. MDH also added coverage for providers who have
  appropriate equipment to perform more extensive presumptive drug testing in their office. Please
  contact Optum Maryland if you have questions associated with covered drug testing changes.
- Applied behavioral analysis (ABA) is covered for children with autism spectrum disorder. Contact mdh.aba@maryland.gov for information or referrals.
