

New Mexico 2023 Medicare Advantage plan changes

Annual benefit changes for Medicare Advantage plan members under Amerigroup Community Care of New Mexico, Inc. will be effective January 1, 2023.

The following is a summary of these changes. Complete details are in the member's *Evidence of Coverage (EOC)*. Changes may include medical and Part D benefits, copays, coinsurance, deductibles, formulary coverage, pharmacy network, premiums, and out-of-pocket maximums.

Some group-sponsored Medicare Advantage plan benefits vary from the Medicare Advantage plans offered to individuals. Please refer to the member's *EOC* or call Provider Services at the number on the back of the member's ID card for more benefit details.

2023 highlights

Not all benefits listed below are available to all Medicare Advantage members. Complete details are in the member's *EOC*:



The Inflation Reduction Act:

- The *Inflation Reduction Act* will provide Part D insulins to all members at \$35 or less for 2023. In addition, the following Part D vaccines will be moving to \$0:
 - Tetanus, diphtheria, and pertussis (Tdap)
 - Measles, mumps, rubella (MMR)
 - Chickenpox (Varicella)
 - Japanese encephalitis
 - Hepatitis A and B
 - Shingles (Zostavax and Shingrix)
 - Rabies



Health and fitness tracker:

- For 2023, *Amerivantage Care Access (HMO) (H5746-016)* will offer this as an embedded benefit.



Flex account — active fitness:

- For 2023, *Amerivantage Care Access (HMO) (H5746-016)* will offer flex account — active fitness as an embedded benefit. This is a spending allowance of \$25 each month toward the payment of facility access fees for golf, tennis, or swimming.
