



Changes to the STAR Kids long-term services and supports (LTSS) billing matrix effective December 1, 2022

Summary of change

Effective December 1, 2022, there will be changes to long-term services and supports (LTSS) claims billing due to updates to the service codes on the *STAR Kids LTSS Billing Matrix*. You may refer to the *STAR Kids LTSS Billing Matrix* that is posted on the Texas Health and Human Services (HHS) website: <https://www.hhs.texas.gov/handbooks/star-kids-handbook/appendix-iii-ltss-billing-matrix-crosswalk>

Claims: service code and units

Claims with date of service on or after December 1, 2022, must be submitted with the new HCPCS codes, modifiers, and units. Claims that are not billed using the new HCPCS code, modifiers for dates of service on and after December 1, 2022, will be denied for incorrect service code.

Electronic visit verification (EVV)

Providers must ensure any EVV visits with date of service on or after December 1, 2022, reflect the new HCPCS code and modifiers according to the *STAR Kids LTSS Billing Matrix*. Please contact your EVV vendor if you need guidance or have issues with making updates to the authorization in the EVV system.
