  - Scheduled for August 17, 2020, completion
  - May bill for CMS 2020 replacement code 96165
- EOB from primary payer requirements on various S, H, T codes

- SERI discrepancies, clinical editing updates
  - Estimated completion in September 2020

## **Enhancement funding**

- Amerigroup created an encounter based payment methodology for enhancement funds starting in January 2020.
  - Using historical encounter data for 2019 regions and projected enhancement funding amounts per region, Amerigroup calculated a mental health (MH) and SUD encounter rate by region.
    - Encounters are tallied by a paid (accepted) claim in Q1 of 2020 with a date of services in 2020; enhanced funding per this methodology is only for services in CY2020.
    - Only Medicaid IMC claims are tallied (excludes FCS/non-Medicaid).
    - If valid claims denied, they would be included in subsequent quarter payouts (when provider rebills or we reprocess) as we pull the data by paid claim date.
    - MH and SUD encounters are determined by diagnosis code submitted with the procedure code.



# **Enhancement funding (cont.)**

- Since funds are rooted in the premium, Amerigroup wanted to ensure sustainability of funds by distributing to providers based on *actual* services rendered.
- To date, payments have received a percent increase adjustment to account for the following:
  - Decrease in services due to COVID-19
  - Inappropriate denials due to Amerigroup configuration issues



# Non-Medicaid/general fund state dollars

- General fund state (GFS) dollars are split between the administrative services organizations (ASOs) and MCOs in each region
  - As of July 1, 2020, 80% goes to each ASO in a region and 20% goes to the MCOs in a region.
    - The 20% is distributed to each MCO based on each MCO's market share in a respective region.
- MCOs are contractually required to cover the following non-Medicaid services:
  - Behavioral Health Personal Care (BHPC); formally known as Medicaid Personal Care (MPC)
  - Medical costs associated with a member who has a stay in an Institution for Mental Disease facility for longer than 15 days
- The Amerigroup GFS dollars funds are payable on a fee-for-service (FFS) basis for contracted Amerigroup providers.
  - GFS dollars codes pay FFS regardless of Medicaid contracted payment arrangement with Amerigroup.
  - GFS dollars services do not require prior authorization.

# **Utilization management**

#### Honor Authorization process:

- These are unique and different from prior authorization requests.
- Must use Honor Authorization Request Form.
- Must fax to number on the form: **1-844-887-6356**.
- Requests will be returned to providers if process not followed.

#### New Prior Authorization Request Forms — please use new forms!

- Behavioral health initial review Medicaid
- Behavioral health concurrent review Medicaid
- **Preferred method** to submit/review prior authorization requests is through the Availity Portal\* even if they are not submitted via the portal.
  - Providers can still fax or call in prior authorization requests.
  - Providers may now request administrative bed days for any voluntary inpatient stay request that is denied.

# **Case management/care coordination**

Behavioral health case management requests:

- Call Provider Services (1-800-454-3730) and request a behavioral health case management referral.
- Email the Behavioral Health Case Management team using the shared mailbox — WABHReferrals@amerigroup.com.

Case management services include:

- Hospital discharge planning for ITA and voluntary.
- Crisis contact follow-up with members/providers.
- Coordinating with formal and informal supports.
- Assist with member access to services.
- Case Management team are experienced in adult and children's mental health, SUD and various allied systems.
